Play Dates:	Monday, July 29 and Tuesday, July 30 at <b>Brown Deer Park Golf Course</b> . The tournament will be held rain or shine. (No rain date.)
Eligibility:	The tournament is open to any amateur woman golfer age 16 and older with an established USGA handicap. Participation will be limited to 92 players on a first come first serve basis.
Event:	Two day 18-hole stroke play. Players will be flighted by handicap. Championship flight will play from the previous slope rating of 73.8/132; all other flights will play new tees with a slope rating 69.2/126. Caddies are allowed but not provided. Walking is permitted or carts are available to be rented (\$17 per day). Box lunches will be provided on Monday.  THE TOURNAMENT CHAMPION WILL RECEIVE A SPONSOR'S EXEMPTION TO PLAY IN THE PHC CLASSIC/SYMETRA EVENT AT BROWN DEER ON AUGUST 9-11, 2019.
Rules:	USGA rules are in force and officials will be on the course. <b>Pace of play will be enforced</b> . No metal spikes allowed on the course.
Tee Times:	There will be a crossover both days of play. Monday, July 29 tee times will begin at 12:00 noon. Tuesday, July 30 tee times will begin at 7:00 am. First day tee times can be found on the tournament website ( <a href="mailto:badgermutual.com/bmiwa">badgermutual.com/bmiwa</a> ) starting July 23. (Please include an e-mail address for first day tee times. Second day tee times will be available on the web site on Monday late afternoon.)
Award Presentations:	Gross and Net prizes. Silent Auction, Raffle, and Awards Luncheon will follow after all play is completed on the second day.
Entry:	Entry fee is \$110. Special entry fee of \$100 for students age 16-18. This includes Monday lunch and Tuesday Awards luncheon. Carts can be rented daily from the pro shop \$17/day.
